The theme of this year's UNGA was **"Galvanizing multilateral efforts for poverty eradication, quality education, climate change and inclusion"**.

Lastly, I attended the Sustainable Development Goals (SDG) Hub update side meetings.

PMRC's participation in the UNGA 74 was insightful and inspired us to continually seek to further 'Unlock Zambia's Potential' through core analytical work areas which we have continued to **present through policy reform proposals, monitoring policy and presenting evidence based research to further improve policy formulation in Zambia.** As we continue to participate in such international, continental and regional gatherings, we commit to consistently ensure the institution actualizes the following stated aims; **supporting Government machinery in recommending policy and procedure, encouraging debate on social and economic policy issues critical to poverty reduction and promoting public understanding through research and education.** The Assembly was a great platform, which improved institutional visibility, expanded professional networks and provided a platform for the acquisition of insightful information from other global players.
