HEAD 11: Zambia Police Service


Their mandate:

- The budget includes funding for police technical and specialized services (K391,420,890), a substantial increase over 2023s allocation of K190,791,016 which will help enhance service delivery. This includes the provision of logistical and operational support, procurement of goods and services, and the maintenance of police fleets. These resources will enable the police to effectively carry out their duties and maintain law and order in the country.
- The allocation of funds to Police Medical Services (K831,915) and Police Human Resource Development (173,974,457) is noteworthy. It indicates a commitment to the well-being of police officers and their families through healthcare services. Additionally, investments in training and capacity development will improve the skills and professionalism of the police force.
- Efficient Administrative Support: The budget allocation for management and support services (267,035,487) is essential for providing administrative and management support to the police service's mandated functions. This includes human resources management, financial management, planning, and legal and professional standards. Efficient administrative support is crucial for the effective functioning of the police force.
- Accountability and Transparency: The outputs and targets specified in the budget, such as conducting payroll audits and producing financial reports and audit reports, demonstrate a commitment to accountability and transparency within the police service. These measures can help ensure the responsible use of resources.

Recommendations:

The police service should:



- Improved Rule of Law, Human Rights, and Constitutionalism: Upholding the rule of law, protecting human rights, and promoting constitutionalism are central to the Ministry's mission, ensuring a just and equitable society.

Budget Summary:

In the fiscal year 2024, the Ministry of Home Affairs and Internal Security has allocated a substantial total budget of K548.8 million. This allocation is thoughtfully distributed across several vital programs, each having distinct aims and specific targets, ensuring comprehensive service delivery and security enhancement. Some of these key programmes include:

1. Internal Security Support Services (K36,373,062):

This program is at the heart of ensuring the nation's internal security and public safety. It encompasses various critical functions, including refugee and asylum management, forensic services, and support services. The allocation here

reinforces Zambia's commitment to remaining a peaceful and secure nation.

2. Forensic Services Management (K28,733,863):

Uncovering facts, resolving crimes, and providing expert testimony through forensic analysis and investigations constitute the core of this program. By doing so, it significantly contributes to justice, the rule of law, and the overall security of the nation.

3. Management and Support Services (133,275,321):

This program forms the foundation of the Ministry's operations, ensuring efficient administrative and management support. It covers vital areas such as human resources, financial management, procurement, infrastructure development, and more. These functions are pivotal in facilitating the seamless execution of the Ministry's mandate.

Budget Allocation by Economic Classification:

Personal Emoluments: K233.1 million (42.5%)

Use of Goods and Services: K185.9 million (33.9%)

Transfers: K100.8 million (18.4%)

Assets: K17.1 million (3.2%)

Commission for Refugees: K9.8 million (1.8%)
National Forensic Authority: K2.6 million (0.5%)

Police Public Complaints Commission: K4.4 million (0.8%)

Parole Board: K741,501(0.1%)

This budget allocation also underscores the strategic prioritization of resources:

Personal Emoluments: The allocation of K233.1 million to personal emoluments reflects the commitment to maintaining a well-compensated and motivated workforce. This is crucial for attracting and retaining top talent within the Ministry.

Use of Goods and Services: K185.9 million is directed towards goods and services, fundamental for operational effectiveness. It encompasses a wide range of needs, including logistics, training, and essential supplies to carry out day-to-day tasks.

Transfers: K100.8 million is channeled towards grant-aided institutions, ensuring their financial sustainability and support for various programs.

Assets: K17.1 million is earmarked for acquiring assets, a vital investment contributing to infrastructure and equipment development, thus enhancing the Ministry's capacity to fulfill its mandate.

Commission for Refugees, National Forensic Authority, Police Public Complaints Commission, and Parole Board: These entities receive targeted allocations for their specific functions, demonstrating the Ministry's commitment to fulfilling their respective roles effectively.

Recommendations

To further strengthen good governance and transparency, the Ministry should consider allocating additional resources to mechanisms that promote accountability, such as enhancing the capacity of oversight bodies like the Police

Public Complaints Commission. This will help build trust between the government and the public.

Given the importance of forensic services in upholding the rule of law, the Ministry should prioritize investments in cutting-edge forensic technology and training for personnel. This will not only improve the efficiency of criminal investigations but also contribute to the overall security of the nation.

Internal security and support services play a critical role in maintaining public safety. Regular training and capacity building programs for law enforcement officers and personnel involved in refugee and asylum management can significantly enhance their effectiveness.

Allocate sufficient funds for infrastructure development to ensure that the Ministry has the necessary facilities and equipment to carry out its functions effectively. This includes the construction and maintenance of detention centers, police stations, and other critical infrastructure.

Implement a robust performance monitoring and evaluation system across all programs to assess their effectiveness and impact. Regular evaluations will help identify areas for improvement and ensure that resources are used efficiently.

Foster collaboration and information sharing with other government agencies and international organizations, especially in areas related to migration services and refugee support. This can lead to more coordinated efforts and better outcomes in managing these complex issues.

Allocate resources to public awareness campaigns that educate citizens about their rights, the importance of civil registration, and how to access services provided by the Ministry. Informed citizens are more likely to cooperate with law enforcement and contribute to national security.

Given the increasing importance of cybersecurity in the modern world, consider dedicating resources to bolster the nation's cybersecurity infrastructure. This includes protecting critical government systems and databases from cyber threats.

Continuously review the budget allocation to ensure that resources are allocated efficiently and in alignment with the Ministry's strategic priorities. Adjustments may be necessary based on changing circumstances and emerging threats.

Engage with stakeholders, including civil society organizations and community leaders, to gather input and feedback on the Ministry's programs and services. This can lead to more inclusive and effective policies.
